Our Open Call allows for a continuous submission process until August 2020. The FAIRsFAIR Executive Committee will select the new Champions in two rounds, the first in February 2020 (application deadline 31 January 2020), and the second in September 2020, (application deadline 31 August 2020).

WHAT IS THE EUROPEAN GROUP OF FAIR CHAMPIONS?

An expert group of FAIR data ambassadors selected on the basis of their specialist knowledge and individual merit to play an active role in formulating policy, driving stakeholder engagement, and promoting the adoption of FAIR data practice in Europe.

- Have broad expertise in FAIR policy or practice.
- Bring strong research data advocacy experience and excellent communications skills.
- Are driven to help mobilise the adoption of FAIR data policy.
- Want to share best practice.

- Shape the implementation of data management standards within their own discipline.
- Formulate requirements to be presented directly to the EOSC governing boards.

- Host a FAIRsFAIR workshop on the premises of their institute.
